



GPMCT Camping Policy Great Pond Mountain Wildlands, Orland

Camping is allowed by reservation only at designated campsites in the 4,500-acre Great Pond Mountain Wildlands. The Wildlands is owned and managed by Great Pond Mountain Conservation Trust, a nonprofit land trust conserving land, water and wildlife habitat for the communities of northwestern Hancock County. Mitchville Campsite on Hothole Brook – max 6 people. Single tent site.

Baker Brook Campsite – groups large or small, max 30 people. Several tent sites, lean to. Port-a-john must be rented for groups larger than 12.

Fee: Minimum recommended donation of \$5/site for groups of 5 and under; \$10/site for 6 or more people. GPMCT members given preference.

Additional Information:

- Reservations will be first-come, first-served, with preference given to GPMCT members and volunteers.
- Five-night limit on camping at any one site.
- Campsites are hike-in only – vehicles must be left outside gates and gates will be locked
- Bring water for drinking and cooking; potable water is not available
- Campers will be expected to follow Leave No Trace ethics – pack it in; pack it out!
- Fires are allowed in fire rings only, conditions permitting. **CHECK FIRE DANGER.** Cutting live trees or vegetation is prohibited. Bring in only local firewood (don't transport pests!), or collect small, dead wood from the forest floor. Burn all wood and coals to ash. Put out fires completely.
- Pit toilets are on site and must be used unless you pack waste out (you must rent a port-a-john for groups larger than 12). Bring your own TP. No trash in toilets, please.
- Dogs must be leashed at all times and waste buried away from water sources – porcupines, moose and bears are common!

Camping in the Wildlands is a remote camping experience – you are camping at your own risk! **Be prepared in case of emergency; be aware that cell phone reception is spotty.** The Wildlands is bear country! Take care with food and food scraps; hang food to be safe.

A signed letter of agreement between GPMCT and campers – or supervising adult/s in the case of a group – is required in advance of any camping trip. Nonprofit groups must provide proof of insurance. Please make reservation **at least a week ahead; call to check availability.**

GPMCT's Stewardship Committee reserves the right to refuse any request for camping that they deem unsafe or inappropriate for people or the resource.
